Blue Sky Bridge was established to provide a safe and supportive environment for abuse victims, where a neutral, professionally-led forensic interview provides case information for all participating law enforcement, judicial and social service agencies. Boulder County professionals recognize that child abuse is too vast and complex an issue for one agency to adequately address. Blue Sky Bridge's Children's Advocacy

Program collaborates with other agencies such as law enforcement, the Department of Housing & Human Services, the District Attorney's Office, County Health, Mental Health, and Victim Service Programs to provide a comprehensive, supportive and professional response to child abuse cases.

At Blue Sky Bridge our goal is a community without child abuse. We facilitate a collaborative approach to child abuse investigations while providing child victims and their families with support in a safe and child-focused environment. We strive to make the community safer for all children and families through intervention, education and advocacy.
